### We collect the following data:

- Personal identification information (name, email address, home address, phone number) to be able to process and delivery your order.

### How do we collect your data?

You directly provide us with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

### How will we use your data?

We collect your data so that we can:

- Process your order and manage your account.
- Email you with your order details, updates or any other necessary order-related communication

When we are processing your order, we may send your data to postal and courier service providers.

### How do we store your data?

We securely store your data in data centers, which are run by Exohosting, Kosicka 6, 821 09 Bratislava, Slovakia.

We will keep your data for the period of 24 months. Once this time period has expired, we will delete your data from our systems.

### What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request us for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request us to complete the information you believe is incomplete.

The right to erasure – You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object us processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
